Resident's Rights:

Money and Property:

Each resident has the right to manage personal finances, or if he or she so chooses, to designate another party to manage them for him or her. Residents do not typically need funds in the facility as most things offered in the facility are paid for. Advanced notice is given for things that are not paid for. The beautician can send bills for hair appointments and most other things in the facility can be billed for. If it is felt that money is needed, it can be deposited into the care center resident trust account and given out as needed by the facility bookkeeper. Receipts are kept as funds are issued to residents from the bookkeeper. This is a great alternative to keeping money in resident rooms. At times valuables do come up missing and are found. Most of the time when they are found they have either been misplaced by the resident or taken out of the facility from another family member. This causes large investigations to be completed in the facility and can be avoided by not having things of significant value in the resident rooms.

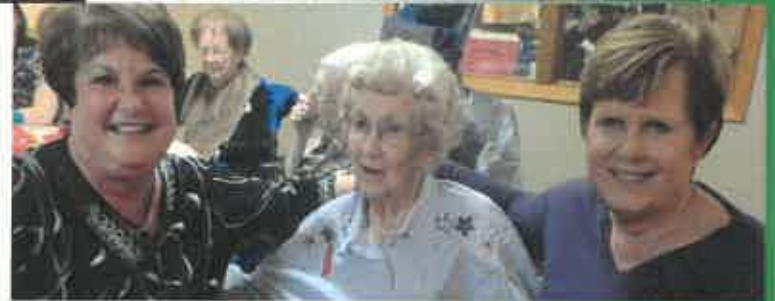
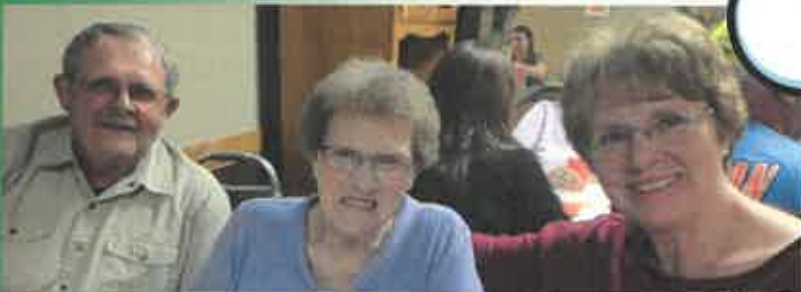
Meals on Wheels:
